Thanks to the Macron law it has now become easier to switch transactions from one bank to another. If you have wanted to switch your account transactions for the last few years but didn't dare as you thought it would be difficult transferring direct debits there is no more need to worry.

CA Britline is here to explain the steps in switching from one bank to another.

(1) The 'Bienvenue' Welcome offer is available to any person aged 18 years or more, having opened a current account with Credit Agricole Normandie before 31/12/2021. Each element of the offer can only be used if the products and/or services are subscribed to within the 6 months following the opening of the account (ask CA Britline for more details). The reimbursements will be credited to your current account from the 7th month following on from the opening of the current account.

(2) Receive 50€ in e-vouchers accepted by a variety of online merchants showing the Isisil logo. Subject to terms and conditions.

(3) Offer available (excluding EKO account) on 1 card only, offer excludes L'Autre card, the Mozaic card, the EKO card and the Prélude card.

(4) 50% discount for the first year on the service package 'Combine and Create' when subscribing to 3 modules. The discount is applied to the overall cost of the 'Combine and Create'. The 'Combine and Create' requires you to have already or at the same time, subscribed to the different contracts necessary for the chosen services.
